Move ups/lateral moves will be allowed as permitted by the class order each day or between trials.

**Start Time:** Trials will start at 8:30 AM and the facility will open one hour prior. Check in will start at 7:30 AM. General Briefing will start at 8:15AM. The facility will close 1 hour after the trial ends.

BGDS reserves the right to change the start time of the trial in the final confirmation due to weather conditions.

Please check the Facebook group if there is any question.

Judge of Record and Event Official dogs may be judged prior to the official start time or as the first blind(s) of the Event.

20% of the MRV will be reserved for committee and worker entries. Entries will be accepted in order of receipt. All entries must be accompanied by entry fees and a correct BHA number to be valid. There will be a \$50.00 fee for all returned checks. Late entries and Day-of entries will be accepted if the trial does not fill. Late and/or Day of Show entries are not a guaranteed entry and will be accepted only up to Judging limits. Confirmations will not be sent for Late entries.

**DAY OF ENTRIES must be made BEFORE the trial starts for the day**

**Class Changes:** Move-ups due to obtaining a title will be accepted between days every day and between trials as class order allows. Class changes other than due to obtaining a title are limited to 2 changes per dog per event weekend.

**You are responsible for knowing the [BARN HUNT RULES](#).** The judge, secretary, trial chair, or any volunteers are **NOT** responsible for telling you the rules and what will result in a Non-Qualifying score.

## Exhibitor Information

Dogs must be leashed or crated when not actively working. Please pick up after your dog and dispose of waste in appropriate containers outside the building.

**Trial Grounds:** Trial grounds include the area around the Black Barn Winery inside the black plank fence. Dogs/competitors are not to walk past the top of the "hill" on the driveway. Map included on last page of premium. Please do not leave the area marked by red. Yellow is the driveway in and the "orange" is where you will park. The trial grounds are a working horse farm and competitors will be asked to leave if they (or their dogs) harass the horses or livestock or do not follow directions not to interact with the animals.

**Ring Description:** The ring is on gravel with two solid walls and two lattice gates. The barn is NOT heated or air conditioned. Please plan for the weather. Blinds are somewhat climate controlled and on concrete floor. There is a wooden support post in the ring.

**Blinds:** I, N, O blinds may be up to 6 dogs, S, CZ8 may be up to 5 dogs, M will be 4 dogs per blind. The blind will be inside the former winery, the blinds are indoors with concrete flooring.

**Safety:** At all times, the safety of the dogs, handlers, and rats is to be of paramount importance. Rats will be humanely handled, and confined safely in aerated PVC tubes; Barn Hunt is not intended to harm or kill rats.

**Crating:** Exhibitors may crate out of their vehicles. There is no room for dogs/crates to be in the barn when the trial is running due to the proximity of the ring.

**Leashes and Collars:** Electronic collars/devices are not allowed. Limited slip martingale and single piece slip collars/leads are allowed. Harnesses are allowed. **Flexi-Leads are not allowed on Ashwood Farm property.**

Dogs may not be brought to the gate in any disallowed collar. Dogs MUST run "naked," without a collar/harness. Dogs should be brought to the ring with collars/harnesses which can be easily and quickly removed and replaced.

**Bitches in season:** Are eligible for entry but will be required to be kept separate from all other dogs and will run at the end of their class/trial. Entry fees for bitches that come into season will be refunded until the closing time if you wish to withdraw. If bringing a bitch in season, please inform the trial secretary prior to the trial and inform all exhibitors at the general briefing.

**Refunds:** No event fee will be refunded if the event cannot open or be completed by reason of riots, civil disturbances, fire, and act of God, public emergency, act of a public enemy, or any other cause beyond the control of the event committee. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Event Committee. Refunds are ONLY allowed if requested before the closing date.

**All refunds for entries that are paid via PayPal will be refunded prior to closing date minus the PayPal fees.**

**Food Services:** There are limited fast food restaurants within driving distance from the event location.

**RV's/Trailers:** There is no availability for RV parking (overnight or day parking) on the trial grounds.

**Payment and Forms:** All entry forms are required to have all information completed including the Barn Hunt number, CORRECT NAME, height; signature, etc. Payment must be sent at the same time. Incomplete forms, nonpayment and returned checks do not constitute a valid entry fee. There is a \$50.00 returned check fee. Entries may be done via our online form or hard copy mailed. No emailed entries accepted.

**Awards:** Ribbons will be awarded for all qualifiers in the regular classes and the Instinct Test. Ribbons will be awarded for first through fourth place in Novice through Master. Title ribbons will also be provided. Special Awards may also be provided.

**Volunteers:** Volunteers are always helpful and appreciated.

### Liability Waiver
